**A Community Partnership Agreement with  
Fair Oaks Responsible Dog Owners Group**

**PURPOSE**

This Community Partnership Agreement is made and entered into January 2005, by and between the Fair Oaks Recreation and Park DISTRICT, hereinafter called the "DISTRICT". The Fair Oaks Recreation Foundation hereinafter called the FOUNDATION and the Fair Oaks Responsible Dog Park Owners Group hereinafter called the "FORDOG".

The purpose of this agreement is to assist "FORDOG" with their quest to encourage individual residents to maintain a social, safe, and leash free environment for their pets.

**General Terms of Agreement**

1. Both parties will designate two (2) persons, a primary and secondary, to act as official spokespersons for the year to facilitate effective communications regarding the use of the resources and conduct events. The Primary representatives will meet (at a minimum) on a quarterly basis.

**The DISTRICT and/or FOUNDATION hereby designates:**

Primary Contact – Administrative Analyst  
Secondary Contact– District Administrator

**In case of emergency, anyone from the FORDOG may contact the DISTRICT.**

2. Either party may terminate the agreement by providing a (30) thirty- day written notice to the other party.
3. For any activities outside of this partnership, "FORDOG" agrees to indemnify, defend and hold harmless the DISTRICT and/or FOUNDATION, its board of directors, officers, agents and employees from and against any and all claims, costs, demands, expenses (including attorney's fees), losses, damages, injuries or liabilities arising from any accident, death or injury whatsoever, or however, caused to any person or property, due to the sole negligence of "FORDOG". It is understood and agreed that such indemnity shall survive the termination of the Agreement.

**AS COMMUNITY PARTNERS**, it is agreed that each partner's responsibilities shall be as follows:



**“FORDOG” shall:**

1. Enforce all facility rules and regulations as it pertains to DISTRICT facility policy and local law. “FORDOG” shall conduct ongoing inspections of the facility and report any safety concerns to the DISTRICT’s Administrative Analyst for review and response.
2. “FORDOG” agrees to assign a Coordinating Committee to oversee the Dog Park and provide input to the DISTRICT’s liaison (Re: Guidelines, operations, and fundraisers).
3. “FORDOG” shall provide adult volunteers to assist with the DISTRICT’s upkeep maintenance and projects as assigned in the Dog Park. The volunteers shall serve in the area of clean-up, maintenance, and other duties determined by the DISTRICT’s Administrative Analyst.
4. Provide to the DISTRICT a written report of activities of “FORDOG” including an annual financial statement, and a list of members of the Coordinating Committee. This report will be submitted by December 1<sup>st</sup> of each year.

**The DISTRICT and/or FOUNDATION shall:**

1. The DISTRICT shall participate in the regularly scheduled meetings of the Coordinating Committee and assist the Coordinating Committee in their activities.
2. The DISTRICT and/or FOUNDATION shall provide space in the DISTRICT general activity publications on an “as requested” basis if this request does not conflict with advertising/publication of other Recreation and Park activities.

**TERM**

This agreement will be automatically renewed, provided that the annual report by FORDOG is submitted, and all other provisions are completed, or the agreement is modified or terminated.

This Agreement contains all the terms and conditions agreed upon by the parties regarding the subject matter of this agreement and supersedes any prior Agreement, oral or written, and all other communications between the parties relating to such subject matter.
